Resolved to approve to implement G.O.Ms. No. 150 dt. 31-8-2006 regarding exemption from payment of examination fee, reduction of pass marks in each subject by 10% for physically challenged (hearing impaired and orthopaedically handicapped) students from the Academic Year 2013-14. Thirty minutes extra time be given to write University

examinations if the orthopaedically handicapped students cannot use their hands freely to write and have to necessarily use a scribe. These regulations will come into force immediately (2013-14).

Sub:- JNTUH Academic Regulations – Certain concessions for award of divisions and for passing UG / PG students - Implementation of the procedure laid down in the orders of JNTUH vide Proceedings No. DE/E3/JNTUH/10 dated 29-06-2010 – Approval – Reg.

6.27.1 The Academic Council was presented with Proceedings No. DEE3/JNTUH/10 dated 29-06-2010 with regard to certain concessions for improvement of division in B. Tech. for passing the examinations. The grace marks to the extent of 0.15% be allowed to change the division as follows:

Change from First class to Distinction, if 69.85% marks are secured.

Change from Second class to First Class, if 59.85% marks are secured.

Change from Pass class to Second class, if 49.85% marks are secured.

With this a total of 0.15% grace marks are added to final year project / seminar to enable the students to get higher class in the B. Tech. courses.

6.27.2 It was also approved by the University to extend 0.15% grace marks facility to the candidates of any degree if she / he passes the subject and obtains the degree. All candidates seeking the benefit from 0.15% grace marks shall apply through proper channel enclosing failed original marks memo. The HoD shall verify from the examination branch whether the candidate is passing if 0.15% grace marks facility is extended, i.e. 0.15% grand total marks of UG / PG courses with fail in maximum two subjects.

A separate approval shall be obtained from the Principal for the eligible candidates for implementation of the above relaxation as and when the applications are received.

6.27.3 In the discussions on the subject, it was brought to the notice of the Academic Council that the concession is now increased to 0.5% from 0.15% by Prof. N.V.Ramana Rao, Registrar and Prof. A. Govardhan, nominees of JNTUH University. The Academic Council further resolved to follow the latest rules of JNTUH University.

It is further decided to implement 0.5% rule for the declaration of pass class to second class, second class to first class and first class to distinction, as stated hereunder:

Change from First class to Distinction, if 69.5% marks are secured.

Change from Second class to First Class, if 59.5% marks are secured.

Change from Pass class to Second class, if 49.5% marks are secured.

However, 0.5% of marks will not be added in the transcripts. The candidate will be given distinction / first class / second class with the obtained marks only.

6.27.4 Either the 0.15% rule or 0.5% rule may be applied whichever is beneficial.

Mr. Ramesh Datla, an eminent industrialist and Member of the Academic Council suggested that there is a need for growth of manufacturing industries in India and for that the capabilities of fresh engineering graduates in the core subjects are to be very good. He requested the Members of Academic Council to see that enough emphasis is given for core subjects in this regard. The Executive Director of SNIST has brought to the notice of the Academic Council that application oriented teaching and project based learning which are introduced from the current Academic Year will help to improve the knowledge of the students in practical applications in their core subjects

MINUTES OF MEETING OF BOARD OF STUDIES
HELD ECM DEPARTMENT AT SNIST ON 15th JULY 2015

Suggestions by Dr. K. Anitha Sheela, JNTUH Nominee

1. It has been recommended to check for the possibility of having 28 credits per semester to maintain consistency in all semesters.
2. Request to check for a possibility of replacing Engineering Drawing – II with either Optimization techniques or Operations Research.
3. It has been suggested to combine English – III & English – IV and consolidate the corresponding credits so as to have scope for adding Computer Organization / Architecture in II year II semester in place of English – IV.
4. Computer Organization / Architecture to be made a core subject instead of a Professional Elective.
5. It has been suggested to rename the title of the subject “Digital Speech Processing” to “Digital Speech Signal Processing” under the Signal Processing stream.
6. It has been requested to check for the possibility of combining QA & LR and consolidating the corresponding credits. It could then be offered for some branches in even semester and some other branches in odd semester thereby giving scope for a reduction in the number of subjects per semester.
7. The current number of subjects per semester seems to over load the student with more number of theory and lab hours.
8. Marks distribution to be looked into and it has been recommended to reduce the marks for projects / seminars.

Suggestions by Other Board Members

1. External members felt the current number of subjects and labs per semester is a heavy load for the students and hence strongly recommended to reduce the number of subjects / labs per semester.
2. External members recommended exploring the possibility of combining English subjects with Technical Seminars.

3. Welding part of Engineering Workshop – I is again included in BME making it redundant.
4. It is strongly recommended that Computer Organization / Architecture should be made a core subject instead of an elective.
5. Similarly DCCN and SE should be made core subjects instead of Professional Electives.
6. It has been suggested to check for a possibility of removing Soft Skills as a subject and combine it with some other humanities subject or with Technical Seminars so as to give scope for replacing it with a core subject like DCCN.
7. It has been suggested to check for a possibility of moving S & S to Professional elective so as to make it in line with the signal processing stream of subjects. Also, this will give chance to accommodate CO as a compulsory subject in II-year II-Semester. Since majority of the students opt for CSE stream in GATE, this will be an added advantage for them to study CO as core subject.
8. It has been suggested to include Multimedia and Applications lab as a choice based lab in III-year I-semester.
9. It has been strongly recommended to combine QA and LR and offer it in alternative semesters for all branches to reduce the number of subjects per semester.
10. It has been suggested to have fewer marks for Projects and Seminars.
11. It has been suggested to offer a 3 ½ year Degree only if the student takes up summer courses.
12. IPR needs to be moved to IV-year II-Semester instead of IV-I because maximum number of credits per semester is only 32 whereas the current distribution shows 34 credits in IV-year I-Semester.
13. It has been requested to distribute a copy of the syllabus of “Environmental Chemistry and Ecology” to all the board members.

Suggestions by Executive Director

1. Our Executive Director wanted to test the CBCS system with existing regulations also and the same has been kindly agreed and approved by all the BOS members.
