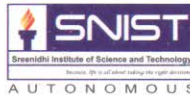

3.1 Dispute Resolution**3.1.1 Negotiation**

Any dispute, difference, controversy or claim between the Parties arising out of or relating to this Agreement or the construction, interpretation, breach, termination or validity thereof ("Dispute") shall, upon the written request of either Party be referred to the authorized representatives of the Parties for resolution. The authorized representatives shall promptly meet and attempt to negotiate in good faith a resolution of the Dispute. In the event that the Parties are unable to resolve the Dispute through negotiation within fifteen (15) Days after service by a Party of such a request, then the Dispute shall be resolved in accordance with the provisions of Clause 12.5.2 below.

3.1.2 Arbitration

- (a) In the event that the Parties are unable to resolve a Dispute as provided in Clause 3.1.1 above, the Dispute shall be finally settled under the rules of arbitration set out under the Indian Arbitration and Conciliation Act, 1996 by sole arbitrator mutually appointed by the Parties.
- (b) The place of arbitration shall be New Delhi only and all the arbitration proceedings shall be conducted in the English language.
- (c) Judgment upon any arbitral award rendered hereunder may be entered in any court having jurisdiction, or application may be made to such court for a judicial acceptance of the award and an order of enforcement, as the case may be.
- (d) Subject to Clause 8, each Party shall bear its respective costs of the arbitration, unless arbitrators otherwise direct in their arbitral award.

3.2 Governing Law and Jurisdiction
