

Memorandum of Understanding

This Memorandum of Understanding (the "Memorandum") is made on 15th February, 2020, by and between CANTILEVERLABS PVT LTD, of T-HUB, Gachibowli, Hyderabad (hereinafter referred to as "Cantilever Labs") and Mr.T.Ch.Siva Reddy, Principal, Sreenidhi Institute of Science and Technology, SNIST.(hereinafter referred to as "Mr.T.Ch.Siva Reddy") for the purpose of achieving the various aims and objectives relating to the placement assistance training services (the "Agreement").

WHEREAS Cantilever Labs and Mr.T.Ch.Siva Reddy desire to enter into an agreement in which Cantilever Labs and Mr.T.Ch.Siva Reddy will work together to complete the Agreement;

AND WHEREAS Cantilever Labs and Mr.T.Ch.Siva Reddy are desirous to enter into a Memorandum of Understanding between them, setting out the working arrangements that each of the parties agree are necessary to complete the Agreement;

1. PURPOSE

The purpose of this Memorandum is to provide the framework for binding contract regarding the placement assistance training services between Cantilever Labs and Mr.T.Ch.Siva Reddy.

2. CO-OPERATION

The activities and services for the Agreement shall include, but not limited to:

a. Cantilever Labs would provide training session and practice tests to students in lieu of employability skill development in the following manner:

IMPORTANT POINTS:

- 8 sessions of 3 hours each for Communication would be added in the above syllabus
- Each class would have a minimum of 70 students and a maximum of 80 students.
- Every day 2 sessions of 3 hours each would be conducted.
- Cantilever Labs would be conducting all the tests, competitions on its platform

4. FINANCE

Fee for the above training programs would be Rs7500 + taxes for a minimum of 300 students which amounts to Rs22,50,000+ tax. For any additional students over and above 300, the fee per student would be Rs7500 + taxes.

Mr.T.Ch.Siva Reddy would maintain the database of students who are entitled to attend the training programs and share the same with Cantilever Labs.

MODE OF PAYMENT:

- 50% of total amount would be paid on or before 15/04/2020.
- 35% of the total amount would be paid on or before 15/07/2020
- 15% of the total amount would be paid on or before 15/08/2020



 In case payment is made after the due date, surcharge of 1.5% per month shall be charged up to the date of payment from the due date. Payment shall be made by Electronic Cash Transfer/ cheque payable to Cantilever Labs Pvt Ltd.

5. DISPUTE RESOLUTION:

If any dispute(s) or difference(s) arises out of or in relation to this MOU, it shall in the first instance be settled amicably between the parties at operating level. In case any dispute is not settled amicably, it shall be referred to the Forum consisting of Mr.T.Ch.Siva Reddy(Principal, Sreenidhi Institute of Science and Technology, SNIST) and Avanish Mundhra (Founder & CEO – Cantilever Labs Pvt Ltd) who will resolve and/or decide the dispute(s), or difference (s) jointly and their decision in that regard shall be final and binding on the parties.

6. NOTICE

Any notice or communication required or permitted under this Memorandum shall be sufficiently given if delivered in person or by certified mail, return receipt requested to the address set forth in the opening paragraph or to such other address as one party may have furnished to the other in writing.

7. Amendment

This Memorandum may be amended or supplemented in writing, if the writing is signed by the party obligated under this Memorandum.

8. UNDERSTANDING

It is mutually agreed upon and understood by and among the parties of this Memorandum that:

- a. In no way does this agreement restrict involved parties from participating in similar agreements with other public/private agencies and individuals.
- b. This Memorandum will be effective upon the signature of both parties.
- c. Either party may terminate its participation in this Memorandum by providing written notice to other party.
