

Memorandum of Understanding

This Memorandum of Understanding (MOU) for PRIME – Placement Fit – Training & Hiring Program made on this 1st Day of February 2022 by and between:

(A) **Sreenidhi Institute of Science & Technology**, Yamnampet, Ghatkesar ,Hyderabad 501301 , India
hereinafter referred to as “Sreenidhi Institute of technology” or the “Client” (which expression unless excluded by or repugnant to the context shall mean and include its successors, its authorized representatives and permitted assignees) of the ONE PART.

(B) Six Phrase at Coimbatore, and having its registered office at No.78-82, Parameswaran Pillai Layout, P.N.Palayam, Coimbatore – 641037, TN India hereinafter referred to as “Six Phrase” or the “Service Provider”, which expression shall unless excluded by or repugnant to the context include its successors and assigns of the OTHER PART.

The Client and the Service Provider shall be individually referred to as “Party” and collectively as “Parties”.

WHEREAS the Client is desirous that the Service Provider provide PRIME – Placement Fit – Training & Hiring Program to its students (hereinafter called “Services”) in accordance with the MoU.

Program Duration: 120 Hours

Target Audience: Third Year First Semester Engineering Students (2019-23)

Program Type: PRIME – Placement Fit – Training & Hiring Program

Fee per Student: Rs.2500 per student (exclusive of taxes)

Program Duration: 150 Hours

Target Audience: Third Year Second Semester Engineering Students (2019-23)

Program Type: PRIME – Placement Fit – Training & Hiring Program

Fee per Student: Rs.2700 per student (exclusive of taxes)

Payment Terms:

As discussed and agreed upon the payment terms as mentioned below to be paid to :

1. Minimum percentage of attendance for each student should be 50%. Payment for below 50% will not be paid.
2. Trainers should remain same for the entire CRT per semester.
3. Based on the performance of 2-2 CRT, 3-1 & 3-2 will be continued.

1. Applicable Law: This MOU shall be interpreted and construed only in accordance with Laws of Republic of India.

2. Jurisdiction: The courts within Coimbatore, Tamil Nadu, India alone will have jurisdiction in respect of the matters arising in connection with and/or under this MOU.

3. No amendment to this MOU shall be valid or be of any affect unless the same is agreed to in writing by both the Parties hereto and specifically stated to be an amendment to this MOU.
